


A SPECIAL MEETING OF THE MAYOR AND THE CITY COUNCIL OF THE



I would like to request a public hearing for a special use exemption for our property at 72791 638 ave southwest of town. I would like to be able to operate our refuse and recycling business from that location. The business currently consists of roll off dumpsters which are placed on the customers property and filled with mainly construction waste. I would like construct a concrete wall and pad on the west side of the property to dump the dumpsters into a semi trailer for transport to the landfill. Smell is not an issue with this because the only rubbish that would be dumped would be construction and demolition waste i.e. boards, sheet rock, plaster, etc. We would also pull out any metals for recycling and they would be stored on the west side of the machine shed out of view from the road. The city of Auburn does not have any place for construction and demolition waste to be disposed of. I have talked to several contractors who are planning to use this service. I plan to plant trees to the west of the road for privacy.
